# Policy for Tuition Fee Waiver (TFW) Scheme of AICTE for the students to pursue PGDM Courses at MDI Gurgaon

#### 1. Objective

To provide financial assistance to meritorious candidates who apply for admissions in our various PGDM Programmes (Except the PGDM-IB/MiM-Dual Degree programme in collaboration with ESCP Europe) belonging to Economically Weaker Sections (EWS) of India to pursue management studies.

#### 2. Scope

As per Scheme the Institute provides a maximum number of 22 TFW scholarships (100% waiver of tuition fees) i.e. maximum 5% of the total intake of the programme, every year to the students pursuing two-year full time PGDM/PGDM- HRM/PGDM-IB/PGDFM-Business Analytics at MDI Gurgaon.

#### 3. Eligibility

The annual income of the parents of the applicant should not exceed Rs.8.0 lakhs.\*

\* The income slab is linked with the applicable Govt. policy for EWS (Economically Weaker Section) wherein the benefits are extended to persons with family income below Rs.8.0 lakhs per annum.

#### 4. Amount of Scholarship

a) An amount equivalent to 100% of the tuition fee of two years will be given in the entire duration of PGDM and the scholarship based on the merit rank of admission.

b) The Scholarship scheme is limited to 22 candidates as mentioned below:

#### 5. Award of Scholarship

The candidates will not be charged any tuition fee during the entire period of programme. Therefore, they will only have to pay the charges other than the tuition fee to the Institute.

#### 6. Procedure for applying for the scholarship

The candidates whose family income is upto Rs. 8.00 Lacs per annum and if they have an authenticated income certificate issued by the Central/State Govt. or by any of the Revenue department, they can apply for the TFW scheme at the time of their admission in the PGDM Programmes. The GP Admissions office will prepare a separate merit list of the candidates who apply for the TFW Scheme. The candidates will be considered for award of TFW Scholarship on the basis of merit of the admission. Maximum up to 5% of the total intake in the respective PGDM Programmes are considered for this scholarship scheme.
