Price should be quoted for “**Supply & Installation of Treadmill (Jogger Stex S23T Commercial use) at MDI Gurgaon**”. Strictly in **Annexure-1** only without any overwriting / erasing / cutting. Use of white fluid/ correction fluid/ correction tape is strictly prohibited.

- I. The price quoted should be inclusive of packing, transportation, insurance, unloading, installation, freight charges up to MDI Gurgaon and exclusive of GST. The price should be quoted in price format (Annexure-1) only.
- II. Price bid should be valid for a minimum period of 30 days.
- III. **The bidder should be ensuring that new treadmill supply & installation within 15 days of confirm in work order.**
- IV. The Conditional bids will not be accepted.
- V. The Institute reserves the right to accept or reject any of the bid received including the lowest one, at any time at its own discretion.
- VI. The Institute, at its discretion, shall have liberty to bifurcate the tendered item, as per the lowest rates received, between the bidders. No correspondence/ enquiry shall be entrained.
- VII. 95% Payment shall be made after receipt of complete items mentioned in the purchase order on submission of the Original Invoice and remaining 5% payment shall be made after its installation and due inspection by the official of MDI Gurgaon. No advance payment shall be made.
- VIII. The agency should provide the details for online transfer of the payment. A copy of the cancelled cheque, PAN No, GST No and address may please be attached with the Financial Bid.
- IX. If any dispute arises, Director, MDI Gurgaon decision shall be final and binding on both the parties.
- X. The Specifications of items offered by the bidder must exactly tally with the specifications mentioned in Annexure -1. Different specification will not be accepted.
