1. The last date of submission of tender on or before 17<sup>th</sup> March,2025 at 03.00 pm. The details of the scope of services/work to be provided are as under: -
2. The rates of items being quoted will include the cost of material, wastage, labour etc. However, the GST, TCS to be paid should be mentioned separately. Thus, the cost of items being quoted in the BOQ will be exclusive of taxes.
3. The schedules of tentative quantities for Items are enclosed at **Annexure-A**. The actual quantity of scrap material will comes out by actual weighment at the time disposal process on "As is Where is" basis. The terms and conditions are given below: -
4. **Terms and Conditions: -**
  - a. The rate quoted shall be inclusive of all types labour etc, however, the GST, TCS to be paid should be mentioned separately.
  - b. Earnest Money Deposit (EMD)-Rs.30,000/- (Rs Thirty thousand only) Demand Draft in favour of "**Management Development Institute Society**"
  - c. The offer price shall be quoted for above items on "as is where basis is".
  - d. You shall make your own arrangements for lifting and carriage of all the material from the MDI Gurgaon.
  - e. The rates quoted shall be final and no negotiation will be done thereafter.
  - f. Once the rates quoted by the agency are accepted by MDI, the agency will be informed to deposit the amount by means of a DD in favor of MDI Gurgaon and once the amount is credited with the institute, the agency will be given one week's time maximum to take the scrap material.
  - g. MDI shall have the right to reject any or all the quotations without assigning any reason whatsoever.
  - h. You may visit the site to assess the namely items material which are being offered for disposal before submitting the quotations the material items are stored at different location of campus.
